
As the Australian Church celebrates the Canonisation of Mary MacKillop, may we be continually inspired by her faith and care for every human being.

Volunteer Medicine, Peru

Last year we reported how, in September 2009, Fr Joe Ruys and a team of volunteers opened the first stage of a Posta Medica (medical centre) in the area known as 'Paraiso', Peru. Stage one consisted of a reception/ admission office, two consultation rooms for general medicine, an office for a social worker/coordinator of the centre and a small chemist.

In the past twelve months, the very generous donations from Melbourne Overseas Missions, as well as fundraising conducted by Fr Joe Ruys while he was on 'holidays' in Jan/Feb of 2010 and other private donations, have enabled the team to greatly enhance the facilities such that now even the Peruvian Ministry of

Health is envious.

The centre has been extended with an additional general medicine consulting room, a dental consultation room, a spacious waiting room which doubles as a lecture theatre and community meeting room, a kitchen, staff dining room (for volunteers) and a storage facility which is also used as a second hand clothes store. Lastly in stage two, stairs have been built that lead to a newly concreted roof which will eventually be

host to a second floor.

A Shining Light in Kanabea, PNG

In October 2010, John Ward, a former priest at Kanabea, piloted a small twin engine Cessna onto the narrow, grassy airstrip of Kanabea Catholic Mission. With him were his wife Louise Ward, a nurse, and Kevin Blake, a retired engineer and secretary of Melbourne Overseas Missions, Dave Tacon, a photographic journalist, and Maurie Morrisson, an electrician from Queensland.

The primary reason for this journey was to lend a helping hand to the community in the shape of medical help and mechanical know-how. The community had been without electricity for four months after an earthquake silenced the hydro-electric generator.

Maurie is a solar specialist and is responsible for maintenance on about 20 solar systems from Cape York to the Gulf of Carpentaria. He has also spent a total of eight years as a volunteer on remote mountain stations in PNG and has worked on Kanabea's generator numerous times over the years. He volunteered his time again at Kevin's request.









In a stone and corrugated-iron shed, Maurie tackled the mission's back-up diesel generator, which had also broken down. The hospital - the only one in the mountains - had had to make do with torches and candles.

In a demonstration of applied bush mechanics, Maurie taught Kanabea's local handyman, Robin Gau, how to make a feeler gauge from an empty beer can - allowing the generator to splutter back to life and light the mission and most importantly the hospital once more.

During the week long visit the team were able to repair the mission's walkabout sawmill and ambulance (a two-decade old Toyota LandCruiser), however the hydro-electric generator is still not up and running. The final diagnosis is that the main shaft is warped - probably by the recent earthquake.

The mission now has the choice of either an expensive short-term solution in having a new shaft machined in Port Moresby or a far more expensive option of a new hydroelectric turbine, or even a complete shift to solar power.

Life Support, Botswana




Notable projects of late include the sewing group setup in Moshopha village which Sr Frances has been running for the past ten years. The group has recently produced uniforms for their choir. Delighted with their outfits, they wanted to show their appreciation by planning a full scale production - decorating a stand, inviting important local officials, then presenting a programme of speeches, dancing and singing followed by a delicious meal. The people of this village are poor, so their gift of a party was deeply touching.

After the Flood, Pakistan

In 2010, MOM forwarded \$10,000 for flood relief to Pakistan where more than 21 million people were affected. This was one of the largest human catastrophes in history with 2000 deaths and 3000 injuries. Water flooded around 20% of Pakistan's land mass damaging around 3 million houses. The need for help is enormous as hundreds of thousands still live in temporary camps having lost their means of living from the destruction of crops, death of cattle and destruction of infrastructure particularly in the districts of Sindah, Punjab, Khyber, Pakhtunkhwa, and Balochistan.



For the past 40 years, Sr Frances Boston, OSU, has lived in Africa, dispensing food, teaching, as well as providing support and self help projects to the community - many of which are affected by HIV/AIDS. MOM commends Sr Frances for all of her hard work and dedication.

> Another great project seeing wonderful success began in 2009 with a group of twelve women doing paper bead making. In the lead up to the 2010 Football World Cup, they received an order from an American football company to make 300 bracelets for a World Cup ceremony honouring Archbishop Desmond Tutu.

> This year Sr Frances' supplementary feeding program for undernourished babies, poor families and women who are HIV positive has also grown currently assisting approximately 60+ people.

Also in Pakistan, Fr Robert McCulloch - who oversees St Elizabeth's Hospital - has received \$25,000 - \$15,000 of this to aid in the replacement of medical equipment. An additional

Focus of Work: MOM concentrates on the Kamea people in the remote mountain villages of the Gulf province Papua New Guinea as well as the poor in Lima Peru. MOM personnel are located at a face-to-face level with villagers and espouse principles based on a Christian motivation of commitment to the poor with strong objectives of gender equality, encouragement, self-help and self-reliance including development of local project management and localisation of staffing.

Country of Regional Focus of Program Activities: Papua New Guinea and Pacific Islands, Peru, Africa, India, Philippines, East Timor and Pakistan.

Educational & Resources: Information on MOM history, objectives and activities is available from the Secretary. Pamphlets and general information is promulgated through Parish Priests to parishioners throughout the Archdiocese of Melbourne.

The Note 2(a): During the financial year, the St Paul's Overseas Aid Fund (OAF) Committee packed and forwarded to Mission Stations a total of 394 boxes (2009: 442 boxes) each weighing an average of 16 kilograms and valued at \$325,230 (2009: \$318,240). The boxes contained various items of medical supplies such as wound dressings and bandages, soap, sheets, blankets and clothing. Apart from the above, Melbourne Overseas Missions (MOM) sent 11 boxes of donated goods to Arimiri school (PNG) to the value of \$1,350.
